Dear Sir or Madam,

Barangay Bel-Air is inviting your company to field a team of your employees for the commercial divisions of the Bel-Air Inter-Color Basketball Tournament 2025.

Teams will be classified into groups based on relative strength as determined by the organizers and the participating teams. Teams will play only those teams in their group for their respective group championships.

Teams will play a minimum of 5 games and potentially a maximum of 6-8 games during the season which will be held between 1st week of October to November 2025. Games will be held on weeknights and weekends at the basketball courts of Bel-Air 3 & 2. As much as possible, we will try to accommodate the schedule preferences of the teams.

The requirements for all teams are as follows:

1. All players must be employees, stockholders, or owners of the company. Contractual employees will be allowed on a case-to-case basis. Please be advised that some teams in the past have been sanctioned heavily by Barangay Bel-Air for fielding ineligible players.
2. Teams must pay a fee of PHP 2,500.00. The fee may be used to cover any fines for defaults and player misconduct of the team throughout the season.
3. Only the first Twenty- Four (24) teams to register, settle their fees, and comply with all the requirements will become official participants. Priority will be given to teams when they comply with all the requirements.
4. **Registration forms, supporting documents, and fees will be accepted until Wednesday, September 10, 2025 at the Barangay Bel-Air office care of Azon San Mateo or EJ Lorilla**
5. Teams must provide their own uniforms. All teams are required to have one dark jersey and one white jersey (or one reversible white and dark jersey) and at least one set of uniform shorts.
6. Teams must have a minimum of 12 players and a maximum of 20 players.
7. Teams must fill up all the requested information in the attached roster form and submit it with Xerox copies of the players' company i.d.'s and a certification from the head of the company's human resources department that all players are employees of the company on or before **Wednesday, September 10, 2025**. The attached team waiver form must also be duly signed by all members of the team.
8. There will be a meeting for all participating teams to be announced at the Barangay Bel-Air Office. All participating teams should send at least one representative.

If your company is interested to join, please fill up the team registration form and submit it together with the associated fees and other requirements to the Barangay Bel-Air Office no later than **Wednesday, September 10, 2025**.
